DIRECTIONS: GPS: 7730 Carlisle Road, Wellsville, PA 17365

From York / Interstate 83:

Proceed west on Rt 30 to Rt 74 west (north) on Rt 74 through Rossville, (Rt. 74 makes left turn at light) York Pointer and Setter grounds on East side of Route 74, before entering Wellsville.

From Harrisburg: South on Rt 15, to Route 74 in Dillsburg, PA. In Dillsburg take turn left at Rt 74 East (South) follow Rt. 74 through Wellsville, the York Pointer and Setter grounds on the right hand side of Route 74(East), before entering Rossville. There is a stone church on the right before the entrance to the grounds and there will be a sign MDGSPC at the drive way.

From Gettysburg: North on Rt 15: In Dillsburg take Rt 74 East (South) through Wellsville, York Pointer and Setter grounds on East side of Route 74, before entering Rossville
