2018 WCA Mid-America Field Classic

Grounds: Typical Texas rangeland with rolling hills, open prairie, hedgerow edges and objectives. Prairie cover is dependent on rainfall and grazing pressure. Two stock tanks, (ponds), and a seasonal creek on course also dependent on rainfall.

Horses: No wrangler will be available at this trial. Water is available on site for participants, horses and dogs.

Camping: Camping on the grounds is permitted. There are 27 electric hook-ups (30 amp) with 9 water pedestals. Fees: \$15/night with water and electric and \$5/night with water only. Primitive toilet facility on site, no shower facility is available.

Food: Food will be available during the running of the trial. Breakfast, lunch, and dinner will be prepared by club members and volunteers. Moderate charges will apply to meals. Exception will be the banquet which will be \$25 a plate.

Directions:

Hubbard, Texas is located northeast of Waco on Hwy 31. At the intersection (stoplight) of Hwy 31 & Hwy 171 in Hubbard, go east about 1/2 mi and turn left on N. Apple Rd. Turn right onto CR 3325. Take the first left onto CR 3322 Loop and follow it around to the new double-gated entrance on the right. When you go past the silo, you're almost there. The entrance is approximately 5.1 miles from the Hubbard stoplight. Remember to stay on 3322. The road makes a 90 degree right at the 3.2 mile-mark. Don't go straight as it is a dead-end road. Please close all gates behind you when entering the grounds.
