OPEN CLASS: For boys and girls who are at least 9 years and under 18 years old on the day of the show and who have won three first place awards, with competition present, in a Novice Class.

MASTER CLASS: For boys and girls at least 9 and under 18 years of age on the day of the show and who have won ten (10) Best Junior wins, with competition from the Open Class. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

BEST JUNIOR HANDLER: The Junior Handler placed first in each of the regular Junior Showmanship Classes, if undefeated in any other Junior Showmanship Class at that show, shall automatically be eligible to compete.
