



POST DATED AND RETURNED CHECKS do not constitute a valid entry fee. The Show Secretary will add a collection fee to the amount of each returned check. The returned check MUST BE MADE GOOD by cash or money order BEFORE the dog(s) will be allowed in the ring. Any person that issues a check that is returned for non-payment, will be required to pay a fine of \$25.00 per check and all items with which check or checks were issued shall then be paid by cash, money, or cashier's check.

CONDITIONAL, UNSIGNED, INCOMPLETE ENTRIES received without fees will not be accepted.

OWNERS ARE RESPONSIBLE for errors on entry blanks and for entering the same dog twice. No refunds for duplicate entries. ENTRIES NOT ON OFFICIAL AKC FORMS or photocopies of entry forms without rules and agreement on reverse side of Official AKC entry form are NOT acceptable

CHANGES, ADDITIONS, CORRECTIONS OR CANCELLATIONS to entry forms must be received in writing by U.S. Mail, or by FAX, Signed and Dated by Owner or Agent prior to the close of entries. Not acceptable by Telephone. **ENTRIES MUST BE SUBMITTED** with required entry fee on an Official American Kennel Club Entry Form

Entries submitted in the form of telegrams or by telephone, cannot be accepted.

ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, excused by Judge, or barred from competition by action of the show committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entries fees for duplicate entry or overpayment of entry fees. If because of riots, civil disturbances, fire extreme and/or dangerous weather conditions, and Act of God, public emergency, act of a public enemy, strikes or another acts beyond the control of the Club or Show Secretary it is impossible to open or complete the show, no refund of entry fee will be made.

AN ADMINISTRATIVE FEE of \$2.00 will be charged for all cancellations or changes made prior to closing of entries.

ONLY DOGS THAT ARE ELIGIBLE to be shown under the American Kennel Club rules shall be allowed on the show grounds and

dogs excused form further judging are to be removed promptly.

ALL DOGS SHALL BE held on leash or confined to their crates, except when being judged or when being exercised

THERE SHALL BE NO drilling nor intensive or corrective training of dogs on the show grounds or premises.

DOGS MUST BE READY FOR JUDGING. The Club and its Show Secretary will not be responsible and are not obligated to furnish any service for notifying exhibitors or their agents of breed or class judging. Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

DOGS NEED TO BE AT THE SHOW only at scheduled time for judging and may leave immediately thereafter, unless require for

further judging.

THE CLUB reserves the right to substitute a prize of equal or greater value,

ALL TROPHIES must be claimed the day of the show. None will be mailed or otherwise distributed

CLASS CASH PRIZES will be paid in the ring to the persons showing the dog. Claims for prize money must be made in the ring before the judging of that Breed is over and the Show Secretary's Office is advised at once. Thursday, July 4, 2019

The Western Section of the Weimaraner Club of America's 2019 Show Futurity will be judged at this show. All dogs/bitches entered in the Futurity must be entered in one of the regular or non-regular conformation classes of the Southland Weimaraner Club's Specialty Show on Thursday, July 4, 2019. A \$30.00 entry fee is required to enter the Futurity after the dog/bitch has been properly entered in one of the regular or non-regular conformation classes. Indicate your dog's Futurity Class on the entry form in the space provided for Additional Classes.

Notice: all entries must comply with the WCA Futurity & Maturity Program rules. Exhibitor is solely responsible for knowledge of and compliance with those rules.

Classification

Senior Dog/Bitch - Born on or after June 1, 2017 through September 30, 2017

Intermediate Dog/Bitch - Born on or after October 1, 2017 through Jan. 31, 2018

Junior Dog/Bitch - Born on or after February 1, 2018 through May 31, 2018

The order of judging will be: Junior Dog, Intermediate Dog, Senior Dog, Best Dog in Futurity. Junior Bitch, Intermediate Bitch, Senior Bitch, Best Bitch in Futurity.

After the judging of Best Bitch in Futurity, the Best Dog and Best Bitch will enter the ring together with no further judging to take place. Both winners will share equally in the honors and awards.

Prizes

The Weimaraner Club of America offers the following prizes:

Owner of the sire and the breeder of the Best Dog in Futurity and Best Bitch in Futurity will each receive a Breed Figure on a walnut base. The breeder of the Best Dog in Futurity and Best Bitch in Futurity will each receive a check for \$100.00 in the mail.

Owner of Best Dog in Futurity and Best Bitch in Futurity will each receive a plaque.

Medallions will be awarded for first, second, third and fourth placement in each class.

Rosettes: The Weimaraner Club of America offers Rosettes for first, second, third and fourth placement in each class as well as for the Best Dog in Futurity and Best Bitch in Futurity.

WEIMARANER CLUB OF AMERICA WESTERN MATURITY

Thursday, July 4, 2019

The Western Section of the Weimaraner Club of America's 2019 Show Maturity will be judged at this show. All dogs/bitches entered in the Maturity must have been eligible for a Futurity event and must be entered in one of the regular or non-regular conformation classes of the Southland Weimaraner Club's Specialty Show on Thursday, July 4, 2019. A \$30.00 entry fee is required to enter the Maturity after the dog/bitch has been properly entered in one of the regular or non-regular conformation classes. Indicate Maturity Class on the entry form in the space provided for Additional Classes.

Notice: all entries must comply with the WCA Futurity & Maturity Program rules. Exhibitor is solely responsible for knowledge of and compliance with those rules.

Classification

Maturity Dog/Bitch - Born on or after June 1, 2016 through May 31, 2017. Classes will be divided by sex only.

Placement will be first, second, third and fourth. First place dog will be Best Dog in Maturity. First place bitch will be Best Bitch in Maturity. After the judging of Dogs and Bitches is complete, the best Dog and Best Bitch will enter the ring together with no further judging to take place. Both Winners will share equally in the honors and awards.

Prizes

The Weimaraner Club of America offers the following prizes:

Owner of the sire and the breeder of the Best Dog in Maturity and Best Bitch in Maturity will each receive a Breed Figure on a walnut base. The breeder of the Best Dog in Maturity and Best Bitch in Maturity will each receive a check for \$100.00 in the mail.

Owner of Best Dog in Maturity and Best Bitch in Maturity will each re-

ceive a plaque.

Medallions will be offered for first, second, third and fourth placement in each class.

Rosettes: The Weimaraner Club of America offers Rosettes for first, second, third and fourth placement in each class as well as for the Best Dog in Maturity and Best Bitch in Maturity.

BEST OF BREED COMPETITION

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record. Dogs which according to their owners records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90 day period, the championship of a dog has not been confirmed by AKC, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC.

When quality warrants, after BOB and BOS are awarded, a Select Dog (SD) and Select Bitch (SB) may be chosen from the remaining Champions (Non Regular Class winners that are Champions and Qualify for BOB are eligible) - (WD or WB are not eligible) (AKC Dog Show Rules, Chapter 3, Section 14 Effective 5-12-10)

AWARDS OF MERIT

After awarding Best of Breed, Best of Winners and Best of Opposite Sex, the judge may award up to three (3) Awards of Merit to exhibits in the Breed ring that are, in the judges opinion, outstanding Specimens. The total number of Awards of Merit the judge is allowed is determined by the total number of dogs competing in Best of Breed competition. 1 Award for 5-8 entries, 2 Awards for 9-14 entries, 3 Awards for 15 plus entries. Each recipient will receive a Rosette and a Yearbook

AMATEUR OWNER HANDLER

For dogs that are at least six months of age that are not champions. Dogs must be handled in the class by the registered owner of the dog and is limited to exhibitors who have not, at any point in time, been a professional handler, AKC approved conformation judge, or employed as an assistant to a professional handler. Additionally, members of the immediate family or household of a current professional handler are ineligible for this class (as defined in Chapter 11, Section 13). Professional handlers are defined as any person who belongs to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.

BRED-BY-EXHIBITOR (BBE) CLASS ELIGIBILITY

All dogs entered in the Bred-By Class must be individually registered with the AKC. The person handling the dog must be a breeder of record of the dog and an owner of record of the dog. Family members must be both a breeder and owner of record to exhibit in the class.

BEST PUPPY

Best Puppy will be selected from the First Place Winners of the 6-9 months and 9-12 months Dog & Bitch Classes

BEST VETERAN

Best veteran will be selected from the First Place Winners 7-9 Years and 10 Years and Older Dog & Bitch Classes

NON-REGULAR CLASSES, INVOLVING SINGLE DOG ENTRIES-OFFERED JULY 4TH ONLY

Veteran Classes - Offered for Dogs and Bitches 7-9 Years of age and 10 Years of age and older (divided by sex) . Neutered Dogs and Spayed Bitches may compete in the Veterans Classes only at Independent Specialties. (AKC Dog Show Rules, Chapter 14, Section 8)

Field Trial Class - (divided by sex) offered for dogs and bitches that have place in an AKC licensed or member Field Trial or who have been awarded AKC Hunting Test Title for that have been awarded WCA Field or Water Rating prior to the closing of this show.

<u>Versatile/Versatile Excellent</u> - (divided by sex) offered for dogs and bitches that have been awarded a Versatile or Versatile Excellent rating from the WCA prior to the closing date of this show.

NON-REGULAR CLASSES, INVOLVING MULTIPLE DOG ENTRIES-OFFERED JULY 4TH ONLY

Stud Dog Class - For dogs that have sired two dogs or bitches entered in this show. The award will be based on the merit of the get. The owner of the stud dog need not be the owner of the get. As the judge's decision in this class will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class, will be eligible to compete for Best of Breed by virtue of having won his class. The Stud Dog must appear in the ring with his get and be entered in the Stud Dog Class.

Brood Bitch Class - For bitches that have whelped two dogs or bitches entered in this show. The award will be based on the merits of the produce. The owner of the brood bitch need not be the owner of the produce. As the judges' decision in this class will be based on the merit of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class. The Brood Bitch must appear in the ring with her produce and be entered in the Brood Bitch Class

OWNER-HANDLED BEST OF BREED

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers. All dogs that are owner-handled and are not owned or exhibited by professional handlers* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition by an eligible owner. Professional handlers, household members and current assistants** to professional handlers may not exhibit the dog in any competition during the entire show.

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes. If the Best of Breed winner is Owner-Handled competition eligible, it will automatically be Owner Handled Best of Breed. If the Best of Breed winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed is eligible, the Best of Opposite Sex to Best of Breed will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed. If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed are Owner-Handled competition eligible, and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch. If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose

Owner Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch. If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners. If Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as Owner Handled Best of Breed. If the Best of Winners is eligible, the other Winner is ineligible since it was defeated. No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.

*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. **A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any during the cluster/weekend.

JUNIOR SHOWMANSHIP COMPETITION

NEW RULES EFFECTIVE JANUARY 1, 2005 AKC Junior Handler Numbers are assigned by AKC and required for entry in AKC Junior Handler Number may be obtained by calling the American Kennel Club (919) 816-3776

NOVICE - This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the times of entries close have not won three (3) first place awards, with competition person, in a Novice Class at a licensed or member show.

JUNIOR - A boy or girl who are at least 9 years old and under 12 years old on the day of the show **INTERMEDIATE** - A boy or girl who are at least 12 years old and under 15 years old on day of the show

SENIOR - A boy or girl who are at least 15 years old and under 18 years old on the day of show. **OPEN** - This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, who have won 3 first place awards in a Novice Class in a licensed or member show, with competition present. The winner of a Novice Class shall automatically become eligible, upon notice to the Open Class ring steward, to enter and compete in the Open Class a the same show provided the win is the (3rd) first place award with competition and further providing there are one or more Junior Handlers competing in the Open Class.

JUNIOR - A boy or girl who are at least 9 years old and under 12 years old on the day of the show **INTERMEDIATE** - A boy or girl who are at least 12 years old and under 15 year sold on day of the show

SENIOR - A boy or girl who are at least 15 years old and under 18 years old on the day of show. **MASTER**- This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1 - October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

BEST JUNIOR HANDLER: A club offering Junior Showmanship may offer a prize for Best Junior Handler, provided there will be competition for this award, a minimum, of two class winners present to compete for the award. The prize is described in the Premium List. The Junior Handler place first in each or the regular Junior Showmanship Classes, if undefeated in any other Junior Showmanship Class at that show, shall automatically be eligible to compete for this prize.

JUNIOR HANDLERS who win a third Novice Class after the Closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Show Secretary at least one-half hour prior to the scheduled start of the earliest conformation judging or one-half hour prior to the scheduled start of Junior Showmanship judging at the Show, whichever is earlier.
