The Retrieving and Shooting Rating Tests are held under the rules and procedures of the Weimaraner Club of America

The following is the eligibility rules for the WCA Ratings: Weimaraners that have disqualifying faults (as listed in the current standard for the breed) shall be eligible to compete for or receive ratings provided they are spayed or neutered. PRIOR to being entered in a ratings test, Weimaraners with disqualifying faults must be certified by the National Office as being spayed or neutered and receive a DQF Number. All Weimaraners with AKC ILP numbers are allowed to participate without applying to the National Office. Examination for faults will start before the 1st run.
