ATTENTION EXHIBITORS

The Show Site will be available to exhibitors & vendors at 9:00 a.m. Tuesday, April 9. Dogs must be removed from the show site immediately after judging of the Combined Specialties show on Sunday. Crated dogs will be allowed in the building overnight at owner/agent's risk. Neither the Show Superintendent, Kennel Clubs, nor the Georgia National Fairgrounds & Agricenter will be responsible for any dogs or equipment. Crating in specified areas only. All Crates must be stacked.

In accordance with Ch 11 Sec 11 of the AKC Rules Applying to Dog Shows: Dogs that are not eligible to be shown (under 6 months of age, not pure-bred, etc.) shall not be allowed in the building while the show is in progress, unless showing in the 4-6 Month Beginner Puppy Competition.

All cords must be taped to the floor.

No drop pens or exercise pens allowed inside building!

Bring your own chairs (no chairs available).

Mats, carpets & rugs are prohibited in all grooming areas. Exhibitors may not save grooming space. The show giving clubs reserve the right to rearrange and/or remove any or all equipment of those exhibitors who do not follow these rules or the grooming layout. ALL GROOMING SPACE MUST BE RESERVED IN ADVANCE.

The building gate will be closed each night & reopened at 6:00 am. Security will be present inside the building. No one will be allowed in the building between 11:00 pm & 6:00 am. The front gate will be closed at 11:00 pm & reopened at 6:00 am. Please place identification on your crates and how you can be reached in case of emergency.

NOTE: Crates must be a minimum of 10 ft from rings, so as not to disturb other exhibitors & judging.

Crates suitable to your breed will be allowed at ringside. They must be removed immediately upon the completion of that breed's judging. No crating or grooming near obedience rings.

There are dog bathing facilities with hot & cold water. No force dryers are allowed in the building. Please clean the area after you have finished bathing your dog.

Exhibitors are responsible for the cleanup of their setup areas, which includes parking areas. Fire lanes in parking areas must be maintained at all times. Violators will be towed at the owner's expense.

No dogs are allowed in the eating areas or the restrooms.

No dogs on flexi-leads are allowed in the building.

A Recording Fee of 50 cents for each dog, an AKC Event Service Fee of \$3.00 for the first entry of each dog and an AKC Event Service Fee of \$3.50 for each additional entry of the same dog will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. An AKC Recording fee of \$3.50 for each entry will be required for each dog in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 4) These Fees are paid to the American Kennel Club.

CANADIAN/FOREIGN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

Entries received prior to the published opening date and time of entries or received prior to the publishing of this premium list will be returned without processing.

A service/processing fee of \$7.00 will be charged to each duplicate entry.

Dogs need be present only for scheduled judging and will be released if not needed for further judging.

Dogs allowed in rings during judging only.

Dogs must be ready for judging. Neither the club nor its Superintendents will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

The Club reserves the right to substitute a prize of equal or greater value.

All trophies must be claimed the day of the show - None will be mailed.

All checks issued as prizes are the sole responsibility of the recipient. Lost, stolen and/or misplaced checks will not be replaced. Checks are valid for 90 days. The Superintendent is not able to cash checks nor will they be accepted toward entry fees.

RETURNED CHECKS/DECLINED CREDIT/DEBIT CARDS do not constitute a valid entry fee. Fees must be paid in guaranteed funds. Checks will not be accepted. The Superintendent will add a fee for completing the transaction and/or reprocessing the entries. Repeated occurrences from the same exhibitors may result in their being put on a CASH ONLY basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge or barred from competition by action of the Show Committee.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

The show giving Club, the Show Superintendent, their agents, employees, etc, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees, signatures or the "Agreement" on the reverse side of the Official AKC Entry Form

Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

Refunds of \$4.00 & less will not be issued due to the costs of processing.

An administrative fee of \$2.50 will be charged for all cancellations or changes made prior to closing of entries.

EXHIBITORS NOTE: Please notify Superintendent of any change of address.

POINTS AVAILABLE FOR RESERVE

The Weimaraner Club of America will award at its National Specialty a three-point major to Reserve Winners Dog if the Regular Class Dog entry is twice the required number for a five-point major in the division where the National Specialty is held.

The Weimaraner Club of America will award at its National Specialty a three-point major to Reserve Winners Bitch if the Regular Class Bitch entry is twice the required number for a five-point major in the division where the National Specialty is held.

NON-REGULAR (ADDITIONAL) CLASSES Involving Single Dog Entries

VETERAN DOG CLASS - A Class for Dogs seven (7) years or older. VETERAN BITCH CLASS - A Class for Bitches seven (7) years or older.

Best of Opposite Sex to Best of Breed

Select

Neutered Dogs & Spayed Bitches may be entered in the Veteran Classes at this Specialty.

FIELD DOG CLASS - Dogs that have placed in an AKC Licensed or Member Field Trial or that have been awarded an AKC Hunting Test Title or that have been awarded a WCA Field or Water Rating prior to the closing date of this Show. Entries in the Field Class may NOT neutered.

FIELD BITCH CLASS - Bitches that have placed in an AKC Licensed or Member Field Trial or that have been awarded an AKC Hunting Test Title or that have been awarded a WCA Field or Water Rating prior to the closing date of this Show. Entries in the Field Class may NOT be spayed.

VERSATILE DOG CLASS - Dogs that have been awarded any Versatile or Versatile Excellent Rating from the WCA prior to the closing date of this Show. Entries in the Versatile Class may NOT be neutered.

VERSATILE BITCH CLASS - Bitches that have been awarded any Versatile or Versatile Excellent Rating from the WCA prior to the closing date of this Show. Entries in the Versatile Class may NOT be spayed.

NON-REGULAR (ADDITIONAL) CLASSES Involving Multiple Dog Entries

As the judge's decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.

STUD DOG CLASS - For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the regular classes, or if a Champion of Record in Best of Breed Competition, but MUST be entered in the Stud Dog Class, the Get MUST be entered in one of the regular classes. The Stud Dog shall be considered as one entry and requires one entry fee, this being the regular fee plus the additional class fee if the Stud Dog is entered in another class. The Stud Dog must be shown in the ring with the Get. The class will be judged on the merits of the Get.

BROOD BITCH CLASS - Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get

BRACE CLASS - This class shall be for two dogs of the same beed (a Unit) irrespective of sex, with one or more common owner. The Brace will be judged on consistency. Dogs entered in each Brace Class unit must each also be entered in a regular or non-regular class. Show Brace Class in "Additional Class" portion of the entry form. Please note the AKC registration number or registered name of the other dog making up the brace unit on each entry form. If more than one Brace is entered by identical owner, the dogs comprising EACH Brace Unit must be designated "Brace #1", "Brace #2", etc.

WHAT IS THE MOST VERSATILE WEIMARANER AWARD

This award has been established by the Weimaraner Club of America to recognize the overall versatility of the Weimaraner. The MVW Award will be presented to the Weimaraner that accumulates the most points by placing/qualifying in at least three of the various venues offered at the WCA National Specialty and/or the local club Regional Specialty during the week of Nationals.

How Does It Work?

Dogs must participate and earn points in at least three of the following eight venues (not all venues may be offered every year).

Agility (Standard & JWW Regular or Preferred Classes in Novice, Open, Excellent, or Masters)

Conformation (AKC only, not sweepstakes or Futurity/Maturity)

Obedience (Regular, Graduate Novice/Open, and Versatility Classes Only)

Rally (Regular Classes only)

Tracking

Shooting Ratings

Retrieving Ratings

Hunting Tests

Dogs may be entered in more than three venues. The dog with the highest combined total score for all venues will be awarded Most Versatile Weimaraner. Detailed rules and scoring reposted in the WCA website.

AKC NATIONAL OWNER-HANDLED SERIES

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

All dogs that are owner-handled and are not exhibited in the National Owner-Handled Series by professional handlers* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants to professional handlers may not exhibit the dog in any AKC National Owner-Handled Series competition during the entire show. A current assistant is defined by anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend, however current assistants that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may participate in NOHS.

Owner-Handled Best of Breed will be selected from the dogs that are competing in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed, or in Best of Winners competition.

*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

JUNIOR SHOWMANSHIP COMPETITION

NOVICE JUNIOR CLASS - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have not won three (3) first place awards★, with competition present, in a Novice Class at a licensed or member show

NOVICE INTERMEDIATE CLASS - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have not won three (3) first place awards★, with competition present, in a Novice Class at a licensed or member show.

NOVICE SENIOR CLASS - For Boys and Girls at least 15 and under 18 years of age on the day of the show what the time entries close, have not won three (3) first place awards★, with competition present, in a Novice class at a licensed or member show.
